AN ACT to amend Tennessee Code Annotated, Title 62, Chapters 6, 20, 27, 32 and 35 relative to regulatory boards.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Tennessee Code Annotated, Section 62-6-507(a), is amended by deleting the existing language in its entirety and substituting instead the following:

(a) All licenses, except temporary licenses, shall expire the last day of the twenty-fourth month from the date of issuance.

SECTION 2. Tennessee Code Annotated, Section 62-6-507(c), is amended by deleting the language "twelve (12) months" and substituting instead the language "twenty-four (24) months".

SECTION 3. Tennessee Code Annotated, Section 62-20-112(a), is amended by deleting the existing language in its entirety and substituting instead the following:

(a) All licenses or identification cards shall expire the last day of the twenty-fourth month from issuance or renewal.

SECTION 4. Tennessee Code Annotated, Section 62-27-115(a), is amended by deleting the existing language in its entirety and substituting instead the following:

(a) All licenses shall expire the last day of the twenty-fourth month from issuance or renewal.

SECTION 5. Tennessee Code Annotated, Section 62-27-129(a)(1), is amended by deleting the existing language in its entirety and substituting instead the following:

(1) Define the basic requirements to be not less than twenty-four (24) credit hours every two (2) years in polygraph.

SECTION 6. Tennessee Code Annotated, Section 62-32-312(e)(3), is amended by deleting the language "one (1) year" and substituting instead the language "two (2) years".

SECTION 7. Tennessee Code Annotated, Section 62-32-312(f), is amended by deleting the word "annually" and substituting instead the language "every two (2) years".

SECTION 8. Tennessee Code Annotated, Section 62-32-313(f), is amended by deleting the phrase "twelfth month" and substituting instead the phrase "twenty-fourth month".

SECTION 9. Tennessee Code Annotated, Section 62-32-313(h), is amended by deleting the language "one (1) year" and substituting instead the language "two (2) years".

SECTION 10. Tennessee Code Annotated, Section 62-32-313(k), is amended by deleting the phrase "during the previous year" and substituting instead the language "during the previous two (2) years".

SECTION 11. Tennessee Code Annotated, Section 62-32-317(c), is amended by deleting the language "for one (1) year".

SECTION 12. Tennessee Code Annotated, Section 62-32-318(a)(3), is amended by deleting the phrase "An annual" and substituting instead the word "A".

SECTION 13. Tennessee Code Annotated, Section 62-32-318(a)(5), is amended by deleting the phrase "an annual license fee" and substituting instead the phrase "a license fee".

SECTION 14. Tennessee Code Annotated, Section 62-32-318(a)(7), is amended by deleting the word "annual".

SECTION 15. Tennessee Code Annotated, Section 62-32-313(j), is amended by deleting the language "one (1) year" and substituting instead the language "three (3) months".

SECTION 16. Tennessee Code Annotated, Section 62-32-317(f), is amended by deleting the language "one (1) year" and substituting instead the language "three (3) months".

SECTION 17. Tennessee Code Annotated, Section 62-35-126(f), is amended by deleting the existing language in its entirety and substituting instead the following:

(f) All certifications shall expire the last day of the twenty-fourth month from issuance or renewal. The commissioner shall establish reasonable fees for the timely renewal of certifications.

SECTION 18. Tennessee Code Annotated, Section 62-35-140, is amended by deleting the existing language in its entirety and substituting instead the following:

Every certified trainer must complete twelve (12) hours of continuing education approved by the commissioner every two (2) years as a prerequisite for renewal. Proof of such continuing education must be submitted to the commissioner in conjunction with the application for renewal.

SECTION 19. This act shall take effect upon becoming a law, the public welfare requiring it.
