AN ACT to amend Tennessee Code Annotated, Title 49, relative to education.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Tennessee Code Annotated, Section 49-8-101(a), is amended by deleting the subsection in its entirety and by substituting instead the following:

(a) There is hereby established a state university and community college system to be composed of Austin Peay State University; Chattanooga State Community College; Cleveland State Community College; Columbia State Community College; Dyersburg State Community College; East Tennessee State University; Jackson State Community College; Middle Tennessee State University; Motlow State Community College; Nashville State Community College; Northeast State Community College; Pellissippi State Community College; Roane State Community College; Southwest Tennessee Community College; Tennessee State University; Tennessee Technological University; the University of Memphis; Volunteer State Community College; Walters State Community College; the statewide system of state technology centers established under Chapter 11, Part 4 of this title, including the state technology centers now established and located at Athens, Covington, Crossville, Dickson, Elizabethton, Harriman, Hartsville, Hohenwald, Jacksboro, Jackson, Knoxville, Livingston, McKenzie, McMinnville, Memphis, Morristown, Murfreesboro, Nashville, Newbern, Oneida, Paris, Pulaski, Ripley, Savannah, Shelbyville, and Whiteville; and other community colleges and state technology centers which may be established.

SECTION 2. Tennessee Code Annotated, Section 49-8-401, is amended by deleting the language "Chattanooga State Technical Community College" and by substituting instead the following:

Chattanooga State Community College

SECTION 3. Tennessee Code Annotated, Section 49-8-901, is amended by deleting the language "Pellissippi State Technical Community College" and by substituting instead the following:

Pellissippi State Community College

SECTION 4. Tennessee Code Annotated, Section 49-8-1001, is amended by deleting the language "Northeast State Technical Community College" and by substituting instead the following:

Northeast State Community College

SECTION 5. Tennessee Code Annotated, Sections 49-8-1301 through 1305, are amended by deleting the language "Nashville State Technical Community College" and by substituting instead the following:

Nashville State Community College

SECTION 6. Tennessee Code Annotated, Sections 49-8-1201 through 1204, and Section 49-8-1206, are amended by deleting the language "Community College in Southwest Tennessee" and by substituting instead the following:

Southwest Tennessee Community College

SECTION 7. Any one-time expenditure of funds required by the conversion of the names shall be from existing institutional funds.

SECTION 8. This act shall take effect July 1, 2009, the public welfare requiring it.
