AN ACT to amend Tennessee Code Annotated, Title 3; Title 4; Title 5; Title 6; Title 7; Title 8; Title 9; Title 12; Title 49; Title 58; Title 64 and Title 68, relative to the office of the Comptroller of the Treasury.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Tennessee Code Annotated, Section 3-2-107 is amended by deleting the last sentence of subdivision (a)(1) in its entirety and substituting instead the following language:

In regard to any bill or resolution affecting local government, the office of the comptroller of the treasury is directed to provide to the fiscal review committee, upon request, the information necessary to determine the fiscal effect of such bill or resolution.

SECTION 2. Tennessee Code Annotated, Section 4-3-104 is amended by deleting subsection (g) in its entirety and substituting instead the following language:

(g) References to the department of local finance or division of local finance are deemed references to the office of the comptroller of the treasury.

SECTION 3. Tennessee Code Annotated, Section 4-3-113 is amended by deleting subsection (h) in its entirety and substituting instead the following language:

(h) References to the state director of local finance, director of local finance, state director of the division of local finance or to the director of the division of local finance are deemed references to the comptroller of the treasury.

SECTION 4. Tennessee Code Annotated, Section 4-3-305 is amended by deleting subsection (a) in its entirety and substituting instead the following language:

(a) The comptroller of the treasury is authorized to administer all or any part of the powers and duties prescribed in subsection (b).

SECTION 5. Tennessee Code Annotated, Section 4-3-305(b) is amended by deleting the word "division" and substituting instead the word "comptroller of the treasury or the comptroller's designee".

SECTION 6. Tennessee Code Annotated, Section 4-3-305 is amended by deleting subsection (c) and redesignating remaining subsections accordingly.

SECTION 7. Tennessee Code Annotated, Section 4-3-305(d)(1) is amended by deleting all references to the language "state director of local finance" and substituting instead the language "comptroller of the treasury, or the comptroller's designee", and is further amended by deleting the second sentence in its entirety and substituting instead the following:

The budgets shall be prepared as required by the comptroller of the treasury or the comptroller's designee and after all necessary changes have been made to the local government's charter, private acts, resolutions, or ordinances, as appropriate.

SECTION 8. Tennessee Code Annotated, Section 4-3-306(a) is amended by deleting the language "department of audit, as a division thereof" and substituting instead the language "office of the comptroller of the treasury".

SECTION 84. Tennessee Code Annotated, Section 64-10-107(a)(1) is amended by deleting the language "state division of bond finance" and substituting instead the language "comptroller of the treasury or the comptroller's designee".

SECTION 85. The Tennessee code commission is requested to revise the appropriate references to "department of local finance", "division of local finance", "state director of local finance", "director of local finance" or "director of the division of local finance" in the code as supplements are issued and volumes are replaced.

SECTION 86. This act shall take effect upon becoming a law, the public welfare requiring it.
