

**PUBLIC CHAPTER NO. 1030**

AN ACT to amend Tennessee Code Annotated, Title 3, Chapter 15, Part 5; Title 4; Title 7, Chapter 86, Part 1; Title 8, Chapter 36, Part 7; Title 9; Title 29, Chapter 37, Part 1; Title 37, Chapter 3, Part 1; Title 50, Chapter 7, Part 4; Title 64; Title 67; Title 68 and Title 71, relative to information and reports submitted to the office of legislative budget analysis.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Tennessee Code Annotated, Section 3-15-510(g), is amended by deleting the language "the TennCare oversight committee and" and by substituting instead the language "the TennCare oversight committee, the office of legislative budget analysis and".

SECTION 2. Tennessee Code Annotated, Section 4-3-716(h), is amended by deleting the language "and the state comptroller." and by substituting instead the language ", the state comptroller and the office of legislative budget analysis."

SECTION 3. Tennessee Code Annotated, Section 4-3-4903(h), is amended by deleting the language "and the comptroller of the treasury." and by substituting instead the language ", the comptroller of the treasury and the office of legislative budget analysis."

SECTION 4. Tennessee Code Annotated, Section 4-7-202, is amended by deleting the following language "and the finance, ways and means committees of the senate and the house of representatives." and by substituting instead the following language "the Finance, Ways and Means Committees of the Senate and the House of Representatives and the office of legislative budget analysis."

SECTION 5. Tennessee Code Annotated, Section 4-51-109(a)(7), is amended by deleting the language "and the board" and by substituting instead the language "the office of legislative budget analysis and the board".

SECTION 6. Tennessee Code Annotated, Section 4-51-109(a)(8), is amended by deleting the language "and the chairs of the education committees of the senate and house of representatives," and by substituting instead the language "the chairs of the Education Committees of the Senate and House of Representatives and the office of legislative budget analysis,".

SECTION 7. Tennessee Code Annotated, Section 4-51-111(c)(2)(A)(i), is amended by deleting the language "and to the members of the select committee on the

Tennessee Education Lottery Corporation." and by substituting instead the language ", the members of the select committee on the Tennessee Education Lottery Corporation and the office of legislative budget analysis."

SECTION 8. Tennessee Code Annotated, Section 7-86-108(a)(1)(B)(i)(a), is amended by adding the following language after the fourth sentence:

A written copy of such report shall be submitted to the office of legislative budget analysis.

SECTION 9. Tennessee Code Annotated, Section 8-36-714(c), is amended by deleting the language "and the chairs of the house standing committees on education and finance, ways and means" and by substituting instead the language ", the chairs of the House Standing Committees on Education and Finance, Ways and Means and the office of legislative budget analysis".

SECTION 10. Tennessee Code Annotated, Section 9-4-5404, is amended by deleting the language "the legislative study committee on block grants" and by substituting instead the language "the legislative office of budget analysis".

SECTION 11. Tennessee Code Annotated, Section 29-37-104(e), is amended by deleting the language "and to the chairs of the house and senate finance, ways and means committees" and by substituting instead the language ", the chairs of the House and Senate Finance, Ways and Means Committees and the office of legislative budget analysis".

SECTION 12. Tennessee Code Annotated, Section 37-3-103(a)(1)(B), is amended by deleting the language "and the finance, ways, and means committee of the house of representatives" and by substituting instead the language "the Finance, Ways and Means Committee of the House of Representatives and the legislative office of budget analysis".

SECTION 13. Tennessee Code Annotated, Section 50-7-451(d)(2), is amended by deleting the language "and the commerce, labor and agriculture committee of the senate" and by substituting instead the language ", the Commerce, Labor and Agriculture Committee of the Senate and the office of legislative budget analysis".

SECTION 14. Tennessee Code Annotated, Section 64-5-213(b), is amended by deleting the language "the chairs of the following standing committees" and by substituting instead the language "office of legislative budget analysis and the chairs of the following standing committees".

SECTION 15. Tennessee Code Annotated, Section 64-7-112, is amended by deleting subdivision (4) in its entirety and by substituting instead the following:

(4) Submit, annually, to the chairs of the Finance, Ways and Means Committees of the Senate and House of Representatives and to the office of legislative budget analysis a work program and budget.

SECTION 16. Tennessee Code Annotated, Section 68-11-1613, is amended by deleting the language "the house of representatives" and by substituting instead the language "the House of Representatives and to the office of legislative budget analysis".

SECTION 17. Tennessee Code Annotated, Section 68-55-306(b), is amended by deleting the language "the house of representatives" and by substituting instead the language "the House of Representatives and to the office of legislative budget analysis".

SECTION 18. Tennessee Code Annotated, Section 71-1-126, is amended by deleting the language "and to such other legislative committees that request such information." and by substituting instead the language "and to such other legislative committees that request such information and to the office of legislative budget analysis".

SECTION 19. Tennessee Code Annotated, Section 71-3-155(F)(2), is amended by deleting the language "to the chair of the finance, ways and means committee of the senate and to the chair of the finance, ways and means committee of the house of representatives." and by substituting instead the language "to the chairs of the Finance, Ways and Means Committees of the Senate and the House of Representatives and to the office of legislative budget analysis".

SECTION 20. Tennessee Code Annotated, Section 71-5-188(a), is amended by deleting the language "and the fiscal review committee" and by substituting instead the language ", the office of legislative budget analysis and the fiscal review committee".

SECTION 21. This act shall take effect upon becoming a law, the public welfare requiring it.
