AN ACT to amend Chapter 53 of the Private Acts of 1985; and any other acts amendatory thereto, relative to the Dickson County highway commission.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Chapter 53 of the Private Acts of 1985, and any other acts amendatory thereto, is amended by deleting Section 5 and by substituting instead the following:

Section 5. The County Highway Commission shall meet on the first Tuesday of each month at the office of the County Highway Engineer. Such other meetings as may be deemed necessary by the chairman, highway engineer, or a majority of the members may be held; provided, however, that no such meeting will be held unless the members of the commission are notified at least forty-eight (48) hours prior to the meeting. Such notice requirement may be waived by a majority vote of the commissioners and the chairman of the commission, in case of an emergency. The County Legislative Body shall be authorized to set, from time to time, the compensation to be paid to the members of the highway commission for each regular monthly meeting and each called meeting attended.

SECTION 2. This act shall have no effect unless it is approved by a two-thirds (2/3) vote of the legislative body of Dickson County. Its approval or nonapproval shall be proclaimed by the presiding officer of the legislative body and certified to the secretary of state.

SECTION 3. For the purpose of approving or rejecting the provisions of this act, it shall be effective upon becoming a law, the public welfare requiring it. For all other purposes, it shall become effective as provided in Section 2.
