AN ACT to amend Tennessee Code Annotated, Title 3; Title 4; Title 9, Chapter 4; Section 36-5-112; Title 37; Section 39-13-530; Section 40-34-107; Title 41; Title 49; Title 50; Title 68 and Title 71, relative to legislative committees.

WHEREAS, Article II, Section 12 of the Tennessee Constitution authorizes the Senate and the House of Representatives to determine the rules of their own proceedings and establishes the judicially recognized principle that one general assembly cannot bind a subsequent general assembly regarding a rule of proceeding; and

WHEREAS, Rule No. 77 of the Senate Rules of Order for the 107th General Assembly prohibits the appointment of any special committee for any purpose if there is a standing committee of the Senate on the same subject; and

WHEREAS, Rule No. 66 of the Rules of Order of the House of Representatives for the 107th General Assembly likewise prohibits the appointment of any special committee for any purpose if there is a standing committee of the House of Representatives on the same subject; and

WHEREAS, Rule No. 78 of the Senate Rules of Order for the 107th General Assembly prohibits the enactment of any legislation to create a special committee to study any topic, matter, duty or area of responsibility assigned to a standing committee of the Senate; and

WHEREAS, by rule and practice, specific standing committees of the Senate and the House of Representatives have long exercised subject area jurisdiction (including oversight responsibilities) regarding state prisons, children, education, health care, taxation, charitable gaming, the education lottery, workers' compensation and long-term care; and

WHEREAS, in recent years, such jurisdiction has been diminished by the statutory creation of various special legislative committees that are also assigned oversight responsibilities pertaining to state prisons, children, education, health care, taxation, charitable gaming, the education lottery, workers' compensation and long-term care; and

WHEREAS, such duplication and fragmentation of committee responsibilities and staff resources promote legislative inefficiencies and wasteful practices; and

WHEREAS, especially in these times of economic hardship and austerity, Tennessee taxpayers demand and deserve their departments of state government to be streamlined, efficient and effective; and

WHEREAS, oversight is a critically important function of the legislative department that is best performed by the appropriate standing committees of the Senate and the House of Representatives; now, therefore,

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:




SECTION 11. This act shall take effect July 1, 2011, the public welfare requiring it.
