WHEREAS, the experience gained from participating in the East Ridge marching band has made a lasting impact on each member; it has also given birth to one student's luminous career as a professional jazz musician, and many others who went on to enjoy consummate careers as band directors; and

WHEREAS, the East Ridge marching band alumni are planning to celebrate this historic occasion at East Ridge High School, March 19, 2011, and the attendees will include current and former members of the East Ridge High School concert, marching or stage bands, majorettes, drum majors, color guard, drill team, flag corps and rifle corps; and

WHEREAS, in recognition of this memorable event, a seminal group of alumni and students will be donating a beautiful display case to the East Ridge History Center, so that the band's past, present, and future achievements can be enjoyed and recognized by the entire community; and




