A RESOLUTION to honor and commend Jake Stansell of Nashville on being named the sixty-seventh President of the Tennessee Road Builders Association.

WHEREAS, as the sixty-seventh President of the Tennessee Road Builders Association; Jake Stansell follows in the footsteps of his father, James Stansell, Jr., who served as president of the TRBA in 1992, making the duo the seventh father-son pair to serve as Presidents of TRBA; and

WHEREAS, a man with an astute business mind, Mr. Stansell previously served the TRBA as First Vice President, Second Vice President, and Treasurer, and as chairman of the TRBA Specialty Division; and

WHEREAS, a pillar of his profession, he has also given of his time and many talents as a member of the Associated Builders & Contractors of Middle Tennessee and is a past president of the local chapter of the American Subcontractors Association; and

WHEREAS, his many professional and personal accomplishments aside, Mr. Stansell is thankful for the love and companionship he shares with his wife, Larissa Stansell, and his three children, Lily Stansell, Anna Reid Stansell, and Everett Stansell; and


