WHEREAS, a remarkable individual who truly appreciates the responsibilities, as well as the privileges of leadership and citizenship, Jamie Woodson has graciously donated her time and energies to many community and civic organizations, including serving with distinction as an Executive Board Member of the Great Smoky Mountain Council of Boy Scouts of America; Advisory Board Member of the Junior League of Knoxville; Board Member of Habitat for Humanity, Hillcrest-Beverly Foundation, YMCA, Great Smoky Mountain Institute at Tremont, John Sevier Foundation, and Epilepsy Foundation of East Tennessee; and member of the Executive Women's Association, Nucleus Knoxville, Tennessee Horizon Network, South Knoxville Rotary, Jefferson County Chamber of Commerce, United States Equestrian Association, Legacy Parks Foundation, Leadership Knoxville Class of 2001, Knoxville Bar Association, Tennessee Bar Association, South Knox Republican Club, West Knox Republican Club, and Volunteer Women's Republican Club; and

WHEREAS, a talented, astute, and productive attorney, Senator Woodson also serves with acumen and alacrity as the General Counsel for Camel Manufacturing Company; and

WHEREAS, no stranger to honors and accolades, Jamie Woodson received the Tennessee Parent-Teacher Association Lifetime Achievement Award for her vigorous efforts to ensure that every Tennessee student receives a world-class education; and

WHEREAS, prior to her exemplary tenure in the Senate, Speaker Pro Tempore Woodson was an outstanding member of the House of Representatives, honorably representing her constituents throughout the 101st through 103rd General Assemblies and rendering sterling service as the House Republican Floor Leader; and
