WHEREAS, on March 26, 2011, after thirty-eight years and five months of service as an Executive Secretary for the State of Tennessee, Ruth Adams took her much-deserved retirement; and

WHEREAS, an active member of her community who enjoys traveling and church activities, Ruth is enjoying her retirement by going to the YMCA daily, taking line dancing lessons, and helping plan her granddaughter's wedding; and

WHEREAS, the widow of the late W.B. Adams, who was a Director of Public Works for the State of Tennessee, Ruth Adams enjoys the love and support of her extensive family and is the proud mother of three children, Sherry Shearer, Pam Duncan and Bo Adams; and the doting grandmother of four grandchildren, Dallas Shearer, Summer Blakely, Adam Duncan, and Taryn Duncan; and


BE IT FURTHER RESOLVED, that an appropriate copy of this resolution be prepared for presentation with this final clause omitted from such copy.
