SENATE JOINT RESOLUTION NO. 354

A RESOLUTION to confirm the appointment of Pamela B. Martin to the Tennessee Ethics Commission.

WHEREAS, Tennessee Code Annotated, Section 3-6-103, provides for the creation of the Tennessee Ethics Commission; and

WHEREAS, such statute further provides that the Governor shall appoint two (2) members to such commission; and

WHEREAS, Governor Bill Haslam has appointed Pamela B. Martin of Mt. Juliet, Tennessee, to fill the remainder of an unexpired term as a member of the Democratic Party on the Tennessee Ethics Commission, such term to expire on December 31, 2012; and

WHEREAS, Pamela B. Martin has an extensive background in the banking industry and presently serves as President of Cushion Employer Services; and

WHEREAS, she previously served as Vice-President for Community Development with SunTrust Bank, in which position she planned, developed, and implemented the Community Development Program for North Nashville's revitalization area; and

WHEREAS, a citizen who is deeply committed to public service, Ms. Martin has served as Vice-Chair of the Conventions and Visitors Bureau, a member of the Nashville Chamber of Commerce Board of Governors, and Chair of Nashville's Tourism and Conventions Commission, and she is presently a Board Member of Project SEE, You Have The Power, the Transit Alliance of Middle Tennessee and Chair of Mayor Karl Dean's Minority Business Advisory Council; and

WHEREAS, Ms. Martin's extensive knowledge of and experience in the private sector will be valuable to the Tennessee Ethics Commission; and

WHEREAS, Tennessee Code Annotated, Section 3-6-103, provides that all members appointed to the Tennessee Ethics Commission by the Governor shall be subject to confirmation by the Senate and House of Representatives; now, therefore,


