WHEREAS, a highly influential figure in his field, Mr. Smith is the only executive to serve as Chairman on both FMI's and the National Grocers Association's Board of Directors; and

WHEREAS, no stranger to honors and accolades, Steven Smith was named the 2009 Grocer of the Year by the Tennessee Grocers and Convenience Store Association and received the Rotary Club's Paul Harris Award; and Food City was the recipient of the 2008 Community Service Award, a prestigious honor given to companies that embody the true spirit of community service; and

WHEREAS, his dedication to his profession is matched only by his involvement in his community; Mr. Smith and Food City graciously support a host of worthy organizations and nonprofits, including Muscular Dystrophy, Boy Scouts of America, United Way, Big Brothers/Big Sisters, American Cancer Society, East Tennessee Children's Hospital, Santa Pals, YWCA, Boys and Girls Clubs, and American Diabetes Association; and

WHEREAS, Mr. Smith's remarkable success as a businessman and civic leader is directly attributable to his reliance on the time-honored values of hard work and common sense, and his uncommon ability to work well with people from all walks of life; and

WHEREAS, Steven Smith is wholly committed to the noble precepts of public service that have earned Tennessee recognition as the "Volunteer State," and it is wholly fitting that he be specially recognized; now, therefore,




