WHEREAS, Ms. Painter has graciously dedicated her time and energies to the daycare, typically working twelve-hour days or more; and

WHEREAS, she and her employees also complete eighteen hours of training each year, with classes that normally take place after the center closes; and

WHEREAS, her numerous accomplishments aside, Loretta Painter is also deeply devoted to her family and she always endeavors to remain true to family values of the highest order; and

WHEREAS, she is the proud matriarch of a family that includes two daughters, four grandsons, and three great-grandsons; and

WHEREAS, during her laudable career in public service, Loretta has made innumerable contributions to the betterment of the State of Tennessee; and

WHEREAS, Ms. Painter's remarkable success as a public servant and civic leader is directly attributable to her reliance on the time-honored values of hard work and common sense and her uncommon ability to work well with people from all walks of life; and

WHEREAS, Loretta Painter is an extremely giving person who often reaches out with compassion to people whom life has treated unkindly, and she epitomizes the ideal of the consummate professional, dedicated public servant, and reliable friend and neighbor; and

WHEREAS, Ms. Painter is wholly committed to the noble precepts of public service that have earned Tennessee recognition as the "Volunteer State," and she should be specially recognized; now, therefore,


BE IT FURTHER RESOLVED, that an appropriate copy of this resolution be prepared for presentation with this final clause omitted from such copy.
