WHEREAS, Sean's display of intellectual aptitude and ambition surely bodes well for his future success, as an English major at either Furman University, Vanderbilt University, Wake Forest University, Rhodes College, or the University of Tennessee at Knoxville; and

WHEREAS, Mr. Stapleton's noteworthy achievement is a tremendous source of pride for his family and friends, Dyersburg High School, and the entire Dyersburg community; and

WHEREAS, Sean Stapleton's dedication to excellence is clearly deserving of the respect, admiration, and commendation of this legislative body; now, therefore,


BE IT FURTHER RESOLVED, that an appropriate copy of this resolution be prepared for presentation with this final clause omitted from such copy.
