WHEREAS, he also rendered sterling service as the Headmaster at Marshall Academy in Holly Springs, Mississippi, and at Old Hickory Academy in Jackson; as the Executive Director of Three Rivers Educational Cooperative in New Albany, Mississippi; as the Assistant Principal and Principal at Middleton High School; and as the Program Specialist with Hardeman County Schools; and

WHEREAS, deeply committed to professional development, Dr. Hopper has served on the Southern Association of Colleges and Schools evaluation team, conducted countless in-service and staff development seminars, and participated in numerous workshops on a wide variety of instructional topics; and

WHEREAS, a highly influential figure in his field, Dr. Hopper is the Chairman of the Tennessee State Textbook Commission and valued member of the Association of Supervision and Curriculum Development's Board of Governance, the Tennessee Association of Supervision and Curriculum Development, the Tennessee Association of Administrators of Special Education, the Tennessee Association of Supervisors of Attendance, and the Tennessee Organization of School Superintendants Board of Directors; and

WHEREAS, believing deeply in his mission of educating, empowering, and encouraging all students to achieve their maximum potential, Dr. Donald Hopper has guided the Hardeman County School System with tremendous acumen and alacrity and leaves the school system in excellent shape for the future; and

WHEREAS, throughout his estimable career, Dr. Donald Hopper has demonstrated the utmost professionalism, ability, and integrity, winning the unbridled respect and admiration of his students, parents, teachers, and school board alike; now, therefore,


