AN ACT to amend Chapter 644 of the Private Acts of 1911; as amended by Chapter 1 of the Private Acts of 1929; Chapter 685 of the Private Acts of 1929; Chapter 410 of the Private Acts of 1949; Chapter 414 of the Private Acts of 1953; Chapter 381 of the Private Acts of 1972; Chapter 330 of the Private Acts of 1974; Chapter 38 of the Private Acts of 1989; Chapter 120 of the Private Acts of 1991, Chapter 20 of the Private Acts of 1999; and any other acts amendatory thereto, relative to increasing the city of Lebanon's purchasing limit before sealed bids are required.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Chapter 644 of the Private Acts of 1911; as amended by Chapter 1 of the Private Acts of 1929; Chapter 685 of the Private Acts of 1929; Chapter 410 of the Private Acts of 1949; Chapter 414 of the Private Acts of 1953; Chapter 381 of the Private Acts of 1972; Chapter 330 of the Private Acts of 1974; Chapter 120 of the Private Acts of 1991, and any other acts amendatory thereto, is amended by deleting from Article XII, Section 3 of the charter the language "Five Thousand Dollars (\$5,000.00)" and by substituting instead the language "Ten Thousand Dollars (\$10,000.00)".

SECTION 2. Chapter 644 of the Private Acts of 1911; as amended by Chapter 1 of the Private Acts of 1929; Chapter 685 of the Private Acts of 1929, Chapter 381 of the Private Acts of 1972, Chapter 38 of the Private Acts of 1989, Chapter 20 of the Private Acts of 1999, and any other acts amendatory thereto, is amended by deleting from Article XIV, Section 1 of the charter the language "Five Thousand Dollars (\$5,000.00)" and by substituting instead the language "Ten Thousand Dollars (\$10,000.00)".

SECTION 3. This act shall have no effect unless it is approved by a two-thirds (2/3) vote of the legislative body of the city of Lebanon. Its approval or nonapproval shall be proclaimed by the presiding officer of the city of Lebanon and certified to the secretary of state.

SECTION 4. For the purpose of approving or rejecting the provisions of this act, it shall be effective upon becoming a law, the public welfare requiring it. For all other purposes, it shall become effective as provided in Section 3.
