PRIVATE CHAPTER NO. 46

HOUSE BILL NO. 2514

AN ACT to amend Chapter 43 of the Private Acts of 2001; and any other acts amendatory thereto, relative to the Charter of the Town of Collierville.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Chapter 43 of the Private Acts of 2001, and any other acts amendatory thereto, is amended in Article IV, Section 4.04 by deleting the following language:

The Board is hereby authorized, by resolution upon the minutes, to fix a salary of the mayor of the Town at a sum not to exceed fifteen thousand dollars (\$15,000) per year; to fix the salary of the vice mayor at a sum not to exceed five thousand four hundred dollars (\$5,400) per year, such sum to be paid in lieu, rather than in addition to, the regular alderman salary; and to fix the salary of the aldermen at a sum not to exceed four thousand eight hundred dollars (\$4,800) per year;

And by substituting instead the following:

The Board is hereby authorized, by resolution upon the minutes, to establish the salaries for the Mayor, Vice-Mayor and Aldermen;


SECTION 2. Nothing in this act shall be construed as having the effect of altering the salary of any incumbent prior to the end of the term for which such public officer was elected.

SECTION 3. This act shall have no effect unless it is approved by a two-thirds (2/3) vote of the legislative body of the Town of Collierville within sixty (60) days of its signing by the Governor of the State. Its approval or nonapproval shall be proclaimed by the presiding officer of the legislative body and certified to the secretary of state.

SECTION 4. For the purpose of approving or rejecting the provisions of this act, it shall be effective upon becoming a law, the public welfare requiring it. For all other purposes, it shall become effective as provided in Section 3.


