## PUBLIC CHAPTER NO. 164

HOUSE BILL NO. 396

AN ACT to amend Tennessee Code Annotated, Title 9, Chapter 4, Part 55; Title 9, Chapter 8 and Title 67, relative to deleting obsolete and antiquated statutory text and references concerning finance.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Tennessee Code Annotated, Section 9-4-5502, is amended by deleting the following language:

Such committee shall make recommendations to the general assembly, no later than January 15, 2001, regarding uses and expenditure of funds in the agricultural reserve account and future payments, if any, received pursuant to the master settlement agreement entered into by Tennessee and other states, United States territories and possessions, and participating tobacco manufacturers, dated November 23, 1998.

SECTION 2. Tennessee Code Annotated, Section 9-4-5503, is amended by deleting the following language:

Such committee shall make recommendations, no later than January 15, 2001, to the general assembly regarding uses and expenditure of funds in the health reserve account and future payments, if any, received pursuant to the master settlement agreement entered into by Tennessee and other states, United States territories and possessions, and participating tobacco manufacturers, dated November 23, 1998.

SECTION 3. Tennessee Code Annotated, Section 9-8-108(a)(9), is amended by deleting the language:

(F) No award shall be made for damages occurring prior to February 4, 1987; provided, that claims made pursuant to this subdivision (a)(9) for damages that occurred between January 1, 1987 and February 29, 1988 must be filed with the board of claims within sixty (60) days of February 29, 1988;

SECTION 4. Tennessee Code Annotated, Section 67-3-206, is amended by deleting the following language:

(b) This section shall cease to be effective until July 1, 2009, at which time this section shall have full effect of law.

SECTION 5. Tennessee Code Annotated, Section 67-4-2008(e), is amended by deleting the following language:

(2) No later than January 20, 2009, the commissioner shall submit to the finance, ways and means committees of the senate and the house of representatives a summary report of the information so compiled. The report shall include analyses of the utilization, costs and benefits of the exemption, as well as findings and recommendations pertaining to continuation of the exemption.

SECTION 6. This act shall take effect July 1, 2013, the public welfare requiring it.


