## PRIVATE CHAPTER NO. 31

HOUSE BILL NO. 1858

AN ACT to amend Chapter 429 of the Private Acts of 1931; as amended by Chapter 526 of the Private Acts of 1933; Chapter 109 of the Private Acts of 1991; Chapter 104 of the Private Acts of 1993; and any other acts amendatory thereto, relative to the charter of the City of Murfreesboro.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Chapter 429 of the Private Acts of 1931, as amended by Chapter 526 of the Private Acts of 1933, Chapter 109 of the Private Acts of 1991, Chapter 104 of the Private Acts of 1993, and any other acts amendatory thereto, is amended in Article V, Section 24, by deleting subsection (a) and substituting instead the following:

(a) Every ordinance shall be in writing when considered for adoption by the City Council. Adoption of an ordinance requires passage by a majority vote of the City Council on two (2) different days with at least one (1) week between the first and second votes.

SECTION 2. This act shall have no effect unless it is approved by a two-thirds (2/3) vote of the legislative body of the City of Murfreesboro. Its approval or nonapproval shall be proclaimed by the presiding officer of the legislative body and certified to the secretary of state.

SECTION 3. For the purpose of approving or rejecting the provisions of this act, it shall be effective upon becoming a law, the public welfare requiring it. For all other purposes, it shall become effective as provided in Section 2.
