## PRIVATE CHAPTER NO. 48

HOUSE BILL NO. 2643

Substituted for: Senate Bill No. 2667

AN ACT to amend Chapter 94 of the Private Acts of 1993, and any other acts amendatory thereto, relative to the charter for the city of Copperhill.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Chapter 94 of the Private Acts of 1993, and any other acts amendatory thereto, is amended by deleting Article III, Section 3.01(e) and substituting instead the following:

(e) Subject to the approval of the board of mayor and aldermen, the mayor shall have the authority to make appointments, promotions and transfers of all employees and to make demotions, suspensions, transfers and removals of officers, department heads and employees and may delegate such personnel authority in these areas as the mayor deems advisable.

SECTION 2. This act shall have no effect unless it is approved by a two-thirds (2/3) vote of the legislative body of Copperhill. Its approval or nonapproval shall be proclaimed by the presiding officer of the legislative body of the city of Copperhill and certified to the secretary of state.

SECTION 3. For the purpose of approving or rejecting the provisions of this act, it shall be effective upon becoming a law, the public welfare requiring it. For all other purposes, it shall become effective as provided in Section 2.


