AN ACT to amend Tennessee Code Annotated, Title 4, Chapter 3, Part 1; Title 4, Chapter 3, Part 14 and Section 8-35-221(a), relative to workforce development.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Tennessee Code Annotated, Section 4-3-104, is amended by adding the following language as a new, appropriately designated subsection:

() References to the elevator division, division of mines, labor standards division, and division of boiler and elevator inspection, are deemed references to the department of labor and workforce development.

SECTION 2. Tennessee Code Annotated, Section 4-3-1402(1), is amended by deleting the subdivision in its entirety and substituting instead the following:

(1) Further the implementation of the federal Workforce Innovation and Opportunity Act, compiled in 29 U.S.C. § 3101 et seq.;

SECTION 3. Tennessee Code Annotated, Section 4-3-1402, is amended by designating the existing language as subsection (a) and adding the following language as new, appropriately designated subsections:

(b) References to federal Workforce Investment Act of 1998 are deemed references to the federal Workforce Innovation and Opportunity Act.

(c) References to the workforce development program are deemed references to the federal Workforce Innovation and Opportunity Act.

SECTION 4. Tennessee Code Annotated, Section 4-3-1404(a), is amended by deleting the language "workforce development program" and substituting instead "federal Workforce Innovation and Opportunity Act, compiled in 29 U.S.C. § 3101 et seq.".

SECTION 5. Tennessee Code Annotated, Section 4-3-1405(a)(1), is amended by deleting the language "Workforce development program" and substituting instead "Federal Workforce Innovation and Opportunity Act, compiled in 29 U.S.C. § 3101 et seq.".

SECTION 6. Tennessee Code Annotated, Section 8-35-221(a), is amended by deleting the language "workforce development program" and substituting instead "federal Workforce Innovation and Opportunity Act, compiled in 29 U.S.C. § 3101 et seq.".

SECTION 7. The Tennessee Code Commission is requested to change appropriate references from the elevator division, division of mines, labor standards division, and division of boiler and elevator inspection, to the department of labor and workforce development as sections are amended and volumes are replaced.

SECTION 8. This act shall take effect July 1, 2016, the public welfare requiring it.
