The State Election Commission meeting was called to order by Chairman Judy Blackburn at NOON, Central Standard Time January 9, 2012. Motion was made, seconded and unanimously approved to adopt the minutes from:

- December 5, 2011 - regularly scheduled meeting
- December 27, 2011 – telephonic meeting

Pursuant to T.C.A. § § 2-12-101 and 2-12-106, motion was made, seconded and unanimously approved to accept the nominations for county election commission appointments as submitted and to leave the nomination process open until 4:30 p.m., Central Standard Time, January 9, 2012. **Old Business**

- Certification of Anita Fowlkes, who took the certification test on December 19, 2011.

Motion was made, seconded and unanimously approved to certify Anita Fowlkes of Dyer County.

**New Business**

- Viewing of voting machines in Christian County, Missouri. Unisyn has requested the State Election Commission and Coordinator view their recently certified voting machine in Christian County, MO. The machine to be viewed has been certified to the 2005 Voluntary Voting Systems Guidelines (2005 VVSG) and has been issued an EAC Certification Number.

Motion was made, seconded and unanimously approved to view the voting machine on February 7, 2012 in Missouri.

**Coordinator Update**


- The Elections Division has started the review of voter registration files with Safety files to identifying illegal aliens. More information
