

Minutes State Election Commission Meeting September 29, 2014

The State Election Commission meeting was called to order by Chairman Judy Blackburn at 11:00 a.m. Central Standard Time, September 29, 2014. The following members and staff were telephonically connected: Chairman Blackburn; Commissioners Barrett, Duckett, Head, Wallace, Wheeler and Younce, Coordinator of Elections Mark Goins; and Kathy Summers, Elections Specialist.

The determination of necessity for conducting the State Election Commission meeting by phone was to make county election commission appointments and discuss any required business.

Pursuant to T.C.A. § § 2-12-101 and 2-12-106, Commissioner Head made a motion, seconded by Commissioner Wheeler and unanimously approved to accept the nominations for county election commission appointments as submitted and to leave the nomination process open until 4:30 p.m. Central Standard Time Monday, September 29, 2014. The State Election Commission met by teleconference at 11:00 a.m., CST on Monday, September 29, 2014 in the Election Division of the William R. Snodgrass - Tennessee Tower.
