

Proposed Rules

Chapter 0520-02-04  
Licensure

Presented herein are proposed amendments of the State Board of Education submitted pursuant to T.C.A.. § 4-5-202 in lieu of a rulemaking hearing. It is the intent of the State Board of Education to promulgate these rules without a rulemaking hearing unless a petition requesting such hearing is filed within thirty (30) days of the publication date of the issue of the Tennessee Administrative Register in which the proposed amendments are published. Such petition to be effective must be filed with the State Board of Education, 9th Floor, Andrew Johnson Tower, 710 James Robertson Parkway, Nashville, Tennessee 37243-1050, and in the Department of State, 8<sup>th</sup> Floor, William Snodgrass Building, 312 8<sup>th</sup> Avenue North, Nashville, Tennessee 37243, and must be signed by twenty-five (25) persons who will be affected by the rule, or submitted by a municipality which will be affected by the rule, or an association of twenty-five (25) or more members, or any standing committee of the General Assembly.

The text of the proposed amendments is as follows:

Amendments

Paragraph (6) of Rule 0520-02-04-.07 Requirements for Endorsements, Grades K-8, On a Teacher License is amended by deleting paragraph (6) Special Reading Teacher (K-8) in its entirety.

Paragraphs (8) and (27) of Rule 0520-02-04-.09 Requirements for Endorsements, Grades 7-12, On a Teacher License are amended by deleting the paragraphs (8) Cooperative Coordinator and (27) Special Reading Teacher (7-12) in their entirety.

Paragraph (8) of Rule 0520-02-04-.10 Requirements for Endorsements, Grades K-12, On a Teacher License is amended by deleting paragraph (8) "Librarian, Effective until August 31, 2000. (Superseded by rule 0520-2-3-.21(8) after August 31, 2000)." in its entirety.
