Regulatory Flexibility Addendum

Pursuant to Public Chapter 464 of the 105th General Assembly, prior to initiating the rule making process as described in § 4-5-202(a)(3) and § 4-5-202(a), all agencies shall conduct a review of whether a proposed rule or rule affects small businesses.

The Commission does not anticipate significant impact to small businesses in Tennessee. The rule establishes different regulations for hunting waterfowl on wildlife management areas and should not affect current business activities.

(2) The projected reporting, recordkeeping and other administrative costs required for compliance with the proposed rule, including the type of professional skills necessary for preparation of the report or record;

The Commission anticipates no record keeping associated with this rule.

(3) A statement of the probable effect on impacted small businesses and consumers;

The Commission anticipates no probable effect to small businesses.

(4) A description of any less burdensome, less intrusive or less costly alternative methods of achieving the purpose and/or objectives of the proposed rule that may exist, and to what extent, such alternative means might be less burdensome to small business;

The Commission is unaware of alternatives to the proposed rule and does not believe the rule as proposed would be burdensome to small businesses.

(5) A comparison of the proposed rule with any federal or state counterparts;

The Commission is not aware of any federal or state counterparts to this rule.

(6) Analysis of the effect of the possible exemption of small businesses from all or any part of the requirements contained in the proposed rule.

The Commission anticipates no probable effect to small businesses and exemptions to this rule would likely not be beneficial.

The rule amendment deletes regulations specific to hunting waterfowl on Bogota WMA.

TCA §70-1-206 grants authority to the Tennessee Wildlife Resources Commission (TWRC) to promulgate rules and regulations.

The Tennessee Wildlife Resources Agency and waterfowl hunters are affected most directly by this rule. The Tennessee Wildlife Resources Agency is urging adoption of this rule.

We are not aware of any opinions of the attorney general or any judicial ruling that directly relate to this rule.

Chapter 1660-01-02
Rules and Regulations Governing Birds

Amendment

Rule 1660-01-02-.02, Migratory Bird Hunting, is amended by deleting paragraph (2), subparagraph (e), Bogota Wildlife Management Area (Except Pool 1), in its entirety.

(e) Bogota Wildlife Management Area (Except Pool 1)

- ~~1. Waterfowl hunting is restricted to temporary blind sites as defined herein.
(i) A temporary blind is either a structure assembled or placed for a hunt or boat that is used for hunting; or, a site consisting of the use of natural vegetation or conditions for concealment for a specified hunt.~~
- ~~2. Hunters are restricted to areas as specified on the TWRA Reservation Card.~~
- ~~3. All hunters in a party are required to hunt in the same temporary blind site for which they were drawn.~~
- ~~4. Decoys and temporary blinds may be left out over the specified hunt but must be removed upon completion of the hunt on the last day.~~
- ~~5. No motorized vessels allowed.~~

6. ~~Hunters are required to park in designated parking areas only.~~
