Chapter 0780-01-56  
Licensing Requirements For Insurance Producers  
Amendment

Rule 0780-01-56.08 Continuing education is amended by adding the following language as a new subparagraph to Paragraph (1):

0780-01-58-.08 Continuing Education

- (c) For any individual who is authorized to sell "property insurance" as defined by T.C.A. § 56-2-201(5) or who is authorized to sell both property and "casualty insurance" as defined by T.C.A. § 56-2-201(2), three (3) hours during each continuing education biennium shall consist of the minimum training requirements of section 207 of the Flood Insurance Federal Reform Act of 2004, 42 U.S.C. § 4011, and basic flood education as outlined at 70 Fed. Reg. 52117, or such later requirements as are published by the Federal Emergency Management Agency.


