Amendments

Rule 0460-1-.05, Continuing Education and C.P.R., is amended by deleting subpart (3) (d) 1. (x) in its entirety and substituting instead the following language, and is further amended by adding the following language as new subparts (3) (d) 1. (xi) and (3) (d) 1. (xii), so that as amended, the new subparts (3) (d) 1. (x), (3) (d) 1. (xi), and (3) (d) 1. (xii) shall read:

(3) (d) 1. (x) Tennessee Department of Health and its affiliated Metropolitan Health Departments, those being the Chattanooga/Hamilton County Health Department, the Davidson County Health Department, the Jackson-Madison County Health Department, the Knox County Health Department, the Memphis and Shelby County Health Department, and the Sullivan County Health Department.

(3) (d) 1. (xi) Tennessee Emergency Management Agency (TEMA).

(3) (d) 1. (xii) Federal Emergency Management Agency (FEMA).
