Application, Registration and Fee Requirements

Amendment

Rule 1177-01-.06 Education and Experience is amended by deleting the language following "university" in subparagraph (1)(b) so that, as amended, the subparagraph shall read as follows:

- (b) Each employee who is responsible for providing probation supervision shall have at least four (4) years of experience in a criminal justice or a social services agency providing counseling services or shall have a bachelor's and/or an associate's degree from an accredited college or university.

Authority: T.C.A. §§ 16-3-909 and 40-35-302(g)(1)(B) and Public Chapter 124 of the Public Acts of 2009.


