Amendments

1370-01-.10 Clinical Fellowships, Clinical Externs, and Supervision is amended by adding subparagraph (4)(g) which shall read as follows:

(4) Clinical Fellows: Supervision Limitations

- (g) Supervising licensees shall be at least two (2) years removed from the completion of their Clinical Fellowship work.
