Licensing Requirements for Insurance Producers

Amendments

Paragraph (3) of Rule 0780-01-56-.08 Continuing Education is amended by deleting subparagraph (e) in its entirety and substituting the following:

- (e) Providers shall electronically transmit a record of those students who have successfully completed a continuing education program to the Department or its designee within thirty (30) days of the program presentation. Providers shall be responsible for paying a course reporting fee of one dollar (\$1.00) for each continuing education credit hour in accordance with the Department's or its designee's internet credit recording procedure.
