Amendment

Rule 0880-11-.06 Fees is amended by deleting paragraph (2) in its entirety and substituting instead the following language, so that as amended, the new paragraph shall read:

- (2) Biennial renewal fee to be submitted every two (2) years when licensure renewal is due. \$250.00


