Amendments

Rule 0620-05-01-.02, Eligibility, is amended by deleting the present language of paragraph (15) in its entirety and replacing it with the following:

(15) Enrollment Caps. CoverKids may impose enrollment caps for the program as a whole or for any category of enrollees when, in its discretion, it determines that either

- (a) sufficient Federal funds will not be available;
- (b) sufficient appropriations from the Tennessee General Assembly will not be available; or
- (c) CoverKids expenditures will exceed the existing funds available for the program.
