Substance of Proposed Rules

Chapter 1050-02  
General Rules Governing and Regulations Governing the Practice of Osteopathy

Amendments

Rule 1050-02-.12, Continuing Education Requirements, is amended by deleting the text of subsection (1)(a) in its entirety and substituting instead the following language, so that as amended, the new subparagraph (1)(a) shall read:

(1)(a) During the two (2) calendar years that precede licensure renewal, all licensees must complete forty (40) hours of courses approved by the Board in Category I-A, II-A and/or I-B continuing medical education as defined in the most current annual American Osteopathic Association Yearbook and Directory.

Authority: T.C.A. § 63-9-107

Rule 1050-02-.12, Continuing Education Requirements, is further amended by inserting the following language as new subparagraph (1)(c) and renumbering the current subparagraphs (1)(c), (1)(d) and (1)(e) as (1)(d), (1)(e) and (1)(f) respectively:

(1)(c) Osteopathic physicians serving as preceptors in any AOA approved osteopathic medical education program may be granted one (1) Category I-B credit for each hour of preceptor work actually performed, up to a maximum of fifty percent (50%) of the total biennially required continuing medical education.
