NuVox Communications, Inc., by their undersigned counsel, respectfully submits this Notice of Adoption of Assumed Business Name. NuVox Communications, Inc. has adopted the assumed business name of "NuVox".


In compliance with TRA Rule 1220-4-1-.08(2)(a), attached hereto is a copy of the acknowledgment of the office of the Tennessee Secretary of State that NuVox Communications, Inc. has registered the assumed business name "NuVox" with the Tennessee Secretary of State.

NuVox meets the requirements of T.C.A. § 65-4-125(j) and therefore was exempted by the Authority on May 9, 2006 from obtaining a surety bond or letter of credit.

Heretofore, NuVox used the assumed business name "NuVox Communications." NuVox asserts that the adoption of this new assumed name will scarcely even be noticed by its customers and that there is no chance of confusion to consumers of the adoption of the assumed business name "NuVox" instead of the prior assumed name "NuVox Communications" or its formal name of "NuVox Communications, Inc." Because of this, NuVox respectfully requests the Authority waive the requirements of a customer notification letter under TRA Rule 1220-4-1-.08(2)(c), under the waiver authority of subsection (3) of such Rule.

THEREFORE, NuVox respectfully requests the Authority to approve its adoption of its assumed business name, to waive the customer notification letter, and to grant such other and further relief to which it may be entitled.
