Scope & Content:

The Tennessee Library Association Records span the period 1897-2009. The majority of the items relate directly to the Tennessee Library Association (TLA) with the remaining items relating to the Nashville Library Club. The collection is composed of financial and administrative records as well as materials relating to annual meetings and conferences. Items in the collection could be beneficial to library students or researchers studying the organization and/or development of local public and regional library systems.

The American Library Association (ALA) materials (Box 1, f. 1-10) contain mostly correspondence between 1941 and 1974. Topics addressed include chapter redesignation, council representatives, federal relations coordinators, and TLA membership. Complete listings of all ALA chapters are also included.

The awards materials (Box 1, f. 19-Box 2, f. 6) consist of items related to the conveying of awards by the TLA. The Louise Meredith School Library Award, the Tennessee Library Association History Book Award, the Tennessee Library Association/Social Issues Resources Series Freedom of Information Award, and the Volunteer State Book Award all have related materials in the collection.

The board of directors materials (Box 2, f. 9-Box 7, f. 1) contain meeting minutes, lists of board members, and correspondence related to board meetings. The meeting minutes give insight into the development and evolution of the Tennessee Library Association from 1959 to the present.

The committee materials (Box 8, f. 9-Box 16, f. 9; Box 63-72) contain information on various TLA committees including the Ad-Hoc Committee, the

Advisory Committee on State Documents, the Archives Task Force, the Bylaws and Procedures Committee, the Certification Committee, the Constitutional Revision Committee, the Continuing Education Program Planning Committee, the Development Advisory Committee, the Executive Committee, the Federal Relations Committee, the Finance Committee, the GODOT Advisory Committee, the Grievance Committee, the Honors and Awards Committee, the Information Committee, the Intellectual Freedom Committee, the Joint Committee on Librarianship as a Career, the Legislative Committee, the Literacy Committee, the Local Arrangements Committee, the Long Range Planning Committee, the Membership Committee, the Nominating Committee, the Planning Committee, the Program Planning Committee, the Public Libraries Section Federal Aid Committee, the Public Library Development Committee, the Publications Committee, the Recruiting Committee, the Resolutions Committee, the Site Selection Committee, the Special Committee on Reorganization, the Special Projects Committee, the Staff Development Committee, the State Documents Committee, and the Tennessee Bibliography Committee. The Membership Record Cards (Box 63-72) have been placed in small boxes at the end of the collection.

The conference materials (Box 16, f. 10-Box 23, f.4; Box 75, f. 2-3) include items related to Tennessee Library Association conferences as well as the Governor's Conference on Libraries, the Governor's Conference on Library and Information Services, the President's Council on Physical Fitness and Sports, the Southeastern Library Association Conference, the Southeastern Regional Conference on Adult Education, the Tennessee Conference on Library and Information Services, the Tri-State Convention, and the White House Conference on Library and Information Services. One item of interest is a letter written by J. [Jesse] Cunningham (Box 17, f. 4). The letter, dated April 5, 1955, discusses inviting a "negro" speaker to the TLA meeting in Chattanooga and deals with the "inter-racial problem" in Memphis. A second item of note is another letter by J. Cunningham dated April 15, 1955. In it, he states that "we would not be interested in scheduling a speaker at an important function who is a negro."

The correspondence (Box 23, f. 7-Box 25, f. 15) includes but is not limited to the following subjects: computer centers, the enactment of county library laws, TLA membership, the Tennessee Secretary of State, the Southeastern Library Association, the State Library Association, TAVA, and *Tennessee Librarian* (a magazine published quarterly by the TLA).

The executive secretary's materials (Box 26, f. 10-14) contain a job description for the executive secretary position as well as applications for the position. Reports from the executive secretary are also included.

The exhibits materials (Box 26, f. 15-19) are comprised of correspondence and other items related to exhibits at the TLA annual conference. A procedure manual for exhibits is also included.

The financial materials (Box 27, f. 1-8; Box 62, v. 1-2) consist of audit reports, budgets, cash books, correspondence, receipt ledger books, reports, and financial statements. The Internal Revenue Service materials concern tax exemption for the organization.

The libraries materials (Box 29, f. 4-41) include correspondence and brochures for several libraries in the state. The correspondence directly relates to the brochures. Most of the brochures center on programs and services that each library provides. The following libraries have included materials: Austin Peay State University, Carson Newman College, Chattanooga Public Library, Chattanooga Public Schools, Country Music Foundation, East Tennessee State University Medical Library, Forked Deer Regional Library, Henry County High School, Knoxville Business College, Knoxville College, Malesus Elementary School, McKenzie School District, Memphis Public Library, Milan City Schools, Milligan College, Morristown College, Middle Tennessee State University, Nashville Public Library, Nolichucky Regional Library, North Side High School, Oak Ridge National Laboratory Library, Presbyterian Day School, Shelby State Community College, Somerville-Fayette County Library, Tennessee Botanical Garden, Tennessee Department of Transportation Library, Tennessee Library for the Blind, Tennessee State Library, Trenton School District, Tusculum College, Tennessee Valley Authority Library, University of the South, University of Tennessee at Chattanooga, University of Tennessee at Knoxville, Vanderbilt, Vanderbilt Medical Library, Watauga Regional Library, and West Jackson Elementary School.

The membership materials (Box 31, f. 2-10) contain correspondence, membership directories, membership lists, and membership renewals. Note that there are related membership resources, including Membership Record Cards in the Membership Committee's materials (Box 13, f. 16-Box 14, f. 10; Box 63-72).

The Nashville Library Club records (Box 31, f. 14-Box 34, f. 4) include correspondence, check registers, committee materials, the Nashville Library Club Constitution, directories, financial records, newspaper clippings, professional literature, and receipt books. Topics addressed include library planning, National Library Week, state aid for public libraries, and the Women's National Book Association. It should be noted that the Tennessee State Library and Archives also houses the Nashville Library Club Records, 1957-1974 (acc. no. 1991-187).

The National Library Week materials (Box 34, f. 5-Box 35, f. 4) concern the annual celebration and promotion of libraries throughout the United States. National Library Week is usually held in April.

The president's materials (Box 37, f. 8-Box 45, f. 5) consist of correspondence, lists of past presidents, and several copies of the president's newsletter. Items of note include information and correspondence regarding the lawsuit filed by the American Civil Liberties Union in Tennessee to challenge the constitutionality of the Tennessee Obscenity Statute (Box 44, f. 11). The lawsuit was filed in the Chancery Court of Davidson County on June 15, 1990.

The associational proceedings (Box 46, f. 1-7) contain meeting minutes spanning the years 1905-1964.

The program materials (Box 47, f. 2-Box 48, f. 2) relate to various meeting programs from the Alabama Library Association, the American Library Association, the Interstate Library Association, the Kentucky Library Association, the New York Library Association, the North Carolina Library Association, the Public School Officers' Association, the Tennessee Federation of Women's

Clubs, the Tennessee Library Association, and the Tennessee State Teacher's Association.

The secretary's materials (Box 50, f. 2-Box 51, f. 2) contain correspondence, receipts, freight bills, and newspaper clippings. Some treasurer's materials for 1938-1948 are also included. It should be noted that related treasurer resources, including information regarding the Tennessee Library Association's tax exempt status, are contained in the treasurer's materials (Box 58, f. 15-Box 61, f. 1).

The sections materials (Box 51, f. 3-Box 53, f. 8) are comprised mostly of correspondence related to various sections (committees, subgroups, etc.) within the Tennessee Library Association. They include resources regarding the American Library Association, children and young adults, college and university libraries, education, government documents, instruction, public libraries, round tables, school and special libraries, staff development, trustees/friends, and the Southeastern Library Association.

The *Tennessee Librarian* materials (Box 55, f. 11-Box 57, f.8) relate to advertising, articles, distribution, and subscriptions for the magazine. *Tennessee Librarian*, is a quarterly publication of TLA. Paid expense vouchers and editor's materials are also included.

The treasurer's materials (Box 58, f. 15-Box 61, f. 1) include Pullman Company tickets for the Louisville and Nashville Railroad and American Airlines tickets. Some of the treasurer's materials, relating to the years 1938-1948, are included with the secretary's materials.

The Work Projects Administration Library Service Project materials (Box 61, f. 9) contain photographs of the WPA bookmobile. One shows the bookmobile in the Watts Barr Defense Area (Rhea, Roane, Loudon and Meigs counties). The other is of a Nashville Public Library bookmobile assisting Vultee Aircraft Defense workers.

Administrative/Biographical History

The Tennessee Library Association (TLA) was organized in Nashville on May 29, 1902, chiefly by members of the Nashville Public Library staff and the Nashville Library Club, in order to promote library interests in the state. In 1905, three years after its organization, TLA had a membership of 41. TLA is a professional organization that offers support for library staff working in Tennessee.
