INTRODUCTION

These papers were loaned for photocopying by the collector, Edgar McNish, of Franklin, North Carolina. The materials measure .42 linear feet. There are no restrictions on the materials. Single photocopies of unpublished writings in the Edgar McNish Collection may be made for purposes of scholarly research.

SCOPE AND CONTENT

This collection, spanning the years 1783-1867, consists of photocopied agreements, contracts, correspondence, deeds, land grants, minutes, statements, surveys, an account of sale, a court ease, a map, a power of attorney, a warrant, and a will.

Most of the papers pertain to the estate of John Rice. Included is his claim dated 1783, the warrant and survey dated 1784, and the original grant of 5,000 acres of land issued by the state of North Carolina in 1789. In 1791, John Rice died leaving an estate of more than 100,000 acres of land in Tennessee. He had appointed William H. Rice, Elisha Rice, Anthony Bledsoe, and Jesse Benton to execute his will dated 1784, however, both Jesse Benton and Anthony Bledsoe died during his lifetime. Elisha Rice proved the will and he and William H. Rice disposed of most of the estate. Included in this collection are several contracts, deeds, and statements involving land transactions between Elisha Rice and John Overton who obtained control of most of the Rice estate.

In 1808, a bill of complaint was entered in the Metro District Court of Equity by Hugh Gwynn, et al against William H. Rice, et al on the grounds that the will of John Rice had no been properly executed. This case was postponed from term to term until 1826 when it was finally decided in favor of the defendants. Other documents concerning the Rice estate involve land transactions between John Overton and his business partners, Andrew Jackson and James Winchester.

This collection also contains papers concerning a tract of land in Nashville, Tennessee, owned by Charles Gerrard. These include the deed from Lardner Clark to Charles Gerrard dated 1789; minutes of meetings of the University of North Carolina Board of Trustees regarding release of the Nashville lot to Elizabeth Gerrard Hunter, dated 1804, 1806, 1810; deed from the University of North Carolina Board of Trustees to Elizabeth Gerrard Hunter, dated 1811; and correspondence of Will Polk to Henry Hunter (husband of Elizabeth Gerrard Hunter) regarding William Anderson's payment for the Nashville lot, dated 1812.

Miscellaneous papers include a contract dated 1827 between William M. Neill, Matthew D. Cooper, and Madison Caruthers establishing the Cooper, Caruthers & Co., New Orleans, Louisiana; correspondence from Thomas J. Stump to Julia Stump McNish (his sister) dated 1859, 1861, 1867; land grant to George W. Crawford, dated 1849; land grant to Noah Wyant, dated 1851; land grant to N.W.W. Yont, dated 1857; and a stock certificate for one hundred shares in the Sewanee Mining Company issued to William B. Shapard, dated 1856.
