INTRODUCTION

William A.J. Moore was a deputy County Court Clerk for Knox County, Tennessee, as well as an insurance agent. He was active in the Baptist Church. This collection is composed primarily of personal correspondence from members of Mr. Moore's family and wide circle of acquaintances.

The materials in this collection measure 2.1 cubic feet. There are no restrictions on the materials. Single photocopies of unpublished writings may be made for purposes of scholarly research.

SCOPE AND CONTENT

The William A.J. Moore Papers are composed of correspondence, bills, printed materials and receipts from the years 1893-1898. Mr. Moore served as an assistant County Court Clerk for Knox County, Tennessee. He was also very active in the Baptist Church and several fraternal organizations.

Much of the correspondence was written to Mr. Moore by his family and acquaintances. Church and family activities, politics, and business matters are the topics encompassed in these letters.

Bills and receipts are another feature of the collection. They reflect Mr. Moore's purchases of goods and services for church work and for the Court Clerk's office. The statements of the Southern Rubber Stamp Works are of some interest because many of them carry the impressions of seals which were made for the use of several notaries public in Knox County.

Within the printed materials, one finds advertisements and brochures for such diverse products as office machines, religious publications, and bicycles. Included are a few pamphlets concerning the Tennessee Centennial Exposition which was held in Nashville in 1897.

Mr. Moore was also employed as an insurance agent. There are a few insurance policies in the collection which were written for Moore and others.

In general, Mr. Moore's papers give a view into the life of an active individual who lived in an urban setting during the late nineteenth century.
