INTRODUCTION

The Erskine-Gordon-Le Conte Papers are centered around Dr. Alexander Erskine (1832-1913), noted physician and professor at the Memphis Hospital Medical College, his wife Margaret Louisa Gordon (1842-1914), and her sister, Mary Brown Gordon Le Conte (ca 1851-1902), wife of Dr. James N. Le Conte.

The materials in this collection measure 3.78 linear feet. There are no restrictions on the materials.

Single photocopies of unpublished writings in the Erskine-Gordon-Le Conte Papers may be made for purposes of scholarly research.

SCOPE AND CONTENT

The Erskine-Gordon-Le Conte Collection, containing approximately 1,000 items, covers the period from 1780 to 1940. The collection is composed of accounts, advertisements, announcements, cards, certificates, church records, correspondence, court records, financial documents, genealogical data, invitations, journals, land records, legal documents, licenses, obituaries, photographs, poetry, programs, recipes, remedies, school records, slave records, and writings.

The major portion of this collection consists of correspondence, spanning the period of the 1800's. The three main correspondents are: Dr. Alexander Erskine, a noted physician and professor of obstetrics and the diseases of children at Memphis Hospital Medical College, Memphis, Tennessee; Lou Gordon Erskine, his wife; and Mary Brown Gordon LeConte, wife of Dr. James N. LeConte and sister of Lou Gordon Erskine. Their letters reflect a genteel way of life in the 1800's, shared by the Erskines in Memphis and Mary LeConte in Columbia. Mrs. LeConte lived most of her life with her brother, George Washington ("Wash") Gordon, on the family farm called Boxwood. In reading their correspondence, one can relive the social whirl of life on Beale Street in Memphis, as well as the pastoral pleasures offered by the rural life in Columbia.

Other letters of particular interest are those written by George Washington Gordon, father of Lou Erskine, Mary LeConte and "Wash" Gordon, in the 1840's and 1850's. From his health resort in Gordon Springs, Georgia, George Washington Gordon relates his progress, as well as the difficulties of his business venture.

Of great interest to any researcher will be the journal of Margaret Erskine, grandmother of Dr. Alexander Erskine. Margaret was born on February 28, 1753, in Pennsylvania. In her journal, she describes her journey through the Cumberland Gap into Kentucky, her capture and subsequent account of her bravery and intelligence, which enabled her to survive the barbaric tortures of her captors. The closing page of the journal offers genealogical data on the Erskine family.

The land records offer an invaluable account of the acquisitions made by the Bradshaw family in the early 1800s, and would be of great interest to a family researcher. Likewise, the slave records and legal documents contain a detailed account of the business dealings of this prosperous family. However, the true value of this collection is the correspondence. A family's history is traced, event by event, year by year, and personalities bloom on the pages of these letters. The overall picture becomes one of a devoted family, sharing their lives through the only means of communication available to them.

- Graduated from the University of Virginia in the “Classical Course”
- Several years spent in hospital work in New York City
- 1858 Moved to Memphis and began the practice of medicine
- 1860 Married Mrs. Augusta Law White, daughter of Mrs. Sarah Gordon
- 1861-1865 Enlisted in the Confederate Army as a surgeon
- Served in the 15th Tennessee Infantry under Colonel Tyler
- Served in the 2nd Tennessee Infantry under Colonel Robertson
- Fought in the Battle of Murfreesboro, Tennessee, and the Battle of Perryville, Kentucky
- In charge of the army hospital at LaGrange, Georgia
- Paroled at Covington, Georgia
- 1868-1873 Dean of Memphis Hospital Medical College, Memphis, Tennessee
- 1872 Married Margaret Louisa Gordon, daughter of George Washington Gordon
- 1885-1906 Professor of Obstetrics and diseases of children at Memphis Hospital Medical College, Memphis, Tennessee
- 1902-1910 Served on the staff of Memphis Hospital, Memphis, Tennessee
- 1913 Died at the age of 81




