## INTRODUCTION

Record Group 1, Tennessee Department of Public Health, 1874-1975, consists of approximately 16 cubic feet of records both loose and bound. These records were transferred through the State Records Center from the Bureau of Health Resources, Department of Public Health, at various times between 1969 through 1980. The documents have been processed on at least two prior occasions according to the previous scope and content note, therefore, the original order is unknown. The condition of the bound volumes varies from poor to acceptable, while the loose documents are in good condition.

Related collections include RG 138, Board of Medical Examiners & Osteopathic Examiners; RG 86, Central State Hospital Records; RG 228, Death Records & Vital Statistics; RG 140, 143, 178-180, 198, and 232-235, Health Facilities Annual Reports; RG 94, Department of Mental Health; RG 97, Department of Public Health Nursing Exams; RG 64, Public Health Photographs; and RG 96, Superfund Fiscal Report-Environmental Protection Agency.

This record group has been microfilmed and most documents were destroyed according to state approved methods. Original documents in series 5, item 53 and series 14, "Epidemics," were retained in their entirety due to the historical importance of their evidence. All documents not discarded can be found in the archive stacks. There are no restrictions to the use of materials in this record group.

## SCOPE AND CONTENT NOTE

The records of the Tennessee Department of Public Health have been transferred to the Tennessee State Library and Archives at various times. The first group of materials containing approximately five cubic feet was processed in 1969. Smaller groups of materials were added over the next few years until finally, in 1980, about 22 cubic feet of material was received and processed into Record Group 1. The record group was never microfilmed. A final processing was necessary in order for the collection to be microfilmed. The collection had been processed by previous archivists into 17 series. The original series titles were retained: 1. "History, Organization of Public Health," 2. "Commissioner's Correspondence," 3. "Acts and Resolutions," 4. "Financial Records," 5. "Conferences, Minutes, and Reports," 6. "Letter Books," 7. "Malaria In Tennessee," 8. "News Releases, Speeches, and Papers," 9. "Policies and Procedures Governing Department of Health," 10. "Tuberculosis, Study Programs and Progress Reports," 11. "Directories," 12. "Tennessee Mid-South Regional Medical Program," 13. "Institutional Records," 14. "Epidemics," 15. "Vital Statistics," 16. "Nursing Section, Tennessee Public Health Association," and 17. "Maps and Drawings." Documents from each series were found scattered in various locations throughout the collection and have now been consolidated in a consecutive manner in the order described in the Container List. The record group currently consists of ten cubic feet of loose and bound documents as well as 34 oversized bound volumes. Most documents were not permanently retained after microfilming, with certain exceptions as described in this scope and content note.

Item 53 in Series 5, "Brief Study of State and County Health Departments," 1927, was retained. This report was compiled by Earle G. Brown, Secretary of the Kansas State Board of Health. The report compares the state health departments of Tennessee, Alabama, North Carolina, Virginia, and Ohio, with specific emphasis on one county from each of those states. Candid photographs of health commissioners, residential housing, and outdoor privies are interesting.

All the documents in Series 14, "Epidemics," have been retained due to their historical significance. This series deals specifically with the yellow fever epidemic of 1879 in Memphis. There are several thousand items, including letters, telegrams, reports, clippings, quarantine forms, broadsides and other materials related to the control of the epidemic. Officers of the State Board of Health anticipated a major fever outbreak prior to 1879. They began efforts to increase their authority through legislation. The board was criticized for the quarantine of the taxing district of Memphis which included a court challenge and local resistance. The board was vindicated in the courts and ultimately reinforced the concept of centralized health planning. Records of the epidemic reveal occasional corruption by medical personnel entrusted with enforcing the quarantine. Folders 12 and 13 in this series will be of particular interest to historians since they give detailed information on the railroad passenger and freight traffic in and out of Memphis during the epidemic. Passenger names and destinations, amounts of freight, descriptions of freight, and the number of boxcars are accounted for daily. Additional information in this series on epidemics of lesser magnitude includes the Knoxville yellow fever outbreak

in 1882. Other items permanently retained include a rare photograph of a Sulphur Fumigator Steam Engine in Series 17.

The materials found in Series 7, "Malaria In Tennessee," contain an assortment of maps, bulletins, and publications on the transmission of malaria. Dr. Robert H. White, health educator and State Historian, collected these materials and authored an unpublished manuscript on the history of malaria with the encouragement of Commissioner of Public Health, Dr. E. L. Bishop and Dr. Harcourt Morgan, Chairman of the Tennessee Valley Authority. Support for publication of the manuscript dwindled with the death of Dr. Bishop and Dr. Morgan.

The public health records of the twentieth century reflect an increasing emphasis on the prevention of disease and an expansion of state responsibility for education and public health. Radio speeches and scripts show early methods of disseminating information to the public. In 1935, the Tennessee General Assembly created the Public Health Council to coordinate planning at the state level.

Vital statistics records show an early effort to collect data on births and deaths. Physicians and morticians were called upon to serve as registrars. Their reports are reflected in the correspondence reports in Series 15 "Vital Statistics." These reports are arranged by counties and list the names, age, race, weight, date, and location of death. Early attempts to keep state death records were tried at various times but the results were not consistent. The law requiring that death records be kept by the state finally took effect in 1914 and continues today. The Bureau of Vital Statistics maintains closed records for 50 years for death, marriage, and divorce records and 100 years for birth records before they are released for public inspection. Additional information on death records can be found in Record Group 228, Department of Public Health Vital Statistics.

Additional resource information can be found in a publication found in the library holdings entitled *Tennessee Public Health, 1877-1977*. This publication is the result of the Tennessee Public Health Centennial Conference of 1977 and includes a good history of public health in Tennessee.

## SERIES DESCRIPTION

1. HISTORY, ORGANIZATION OF PUBLIC HEALTH.  
1874-1944.  
Arranged chronologically.  
Five files contained in this series include by-laws of the State Board of Health possibly from 1910. A comprehensive, undated, hand-written manuscript of the history of the department is included but the author is unknown.
2. COMMISSIONER'S CORRESPONDENCE  
1879-1975  
Alphabetical by subject, then chronological.  
These correspondence files include a broad range of subjects dealing with all aspects of public health as dealt with by the commissioner's office.
3. ACTS AND RESOLUTIONS  
1889-1951  
Alphabetical by subject, then chronological.  
The nine files in this series include proposed acts and resolutions. Included is a copy of the Interstate Stream Conservation Agreement and an official copy of the resolution requesting an investigation of the sanitary condition of the capitol building.
4. FINANCIAL RECORDS  
1893-1973  
Chronological.  
The 15 files of financial records in this series include general expense records, account books, and budgets.
5. CONFERENCES, MINUTES, AND REPORTS  
1877-1975  
Arranged as listed below.  
The 112 files in the series makes this the largest series in the collection. The series begins with correspondence of the Public Health Council, 1933-1975. The remainder is divided into two groups including minutes, 1885-1975, and reports & surveys, 1919-1975. Item 53, "Brief Study of State & County Health Departments, 1927" has been retained permanently. Five minutes books, 1877-1922, are found at the end of this series to facilitate microfilming of these oversized items.
6. LETTER BOOKS  
1879-1901  
Arranged by size, then chronological.  
Fifteen letterbooks are found in this series. The chronological sequence is interrupted at the 7<sup>th</sup> volume due to the fact that the last 9 volumes, 1881-1901, are oversized documents. This was done to facilitate the microfilm process. The earliest of these hand-written books, 1879-1883, are on tissue paper and very difficult or impossible to read because of the poor quality of the original document.

7. MALARIA IN TENNESSEE  
1934-1972  
Unarranged.  
This series consists of 52 files of materials collected by Dr. Robert H. White, State Historian. Dr. White collected these materials and authored an unpublished manuscript on the history of malaria. Folder five contains the manuscript and a letter of explanation of why the book did not get published. The bulletins and periodicals that make up the bulk of this series is a significant collection of information on the transmission of malaria.
8. NEWS RELEASES, SPEECHES, & PAPERS  
1923-1969  
Arranged by subject, then chronological.  
Speeches and radio addresses of an informational nature presented to educate the public on all aspects of public health.
9. POLICIES & PROCEDURES GOVERNING DEPARTMENT OF HEALTH  
1927-1975  
Unarranged.  
37 files of rules, regulations, practices, forms, handbooks, manuals, policies and procedures.
10. TUBERCULOSIS, STUDY PROGRAMS & PROGRESS REPORTS  
1927-1974  
Chronological.  
Seven files of tuberculosis reports, memoranda, commission statements, and a handbook to establish a tuberculosis Control Program by Dr. E. L. Bishop.
11. DIRECTORIES  
Undated, ca. 1975  
One directory of public and private services in Tennessee for the socially, physically, emotionally, and mentally handicapped.
12. TENNESSEE MID-SOUTH REGIONAL MEDICAL PROGRAM  
1968-1972  
Chronological.  
Four files include pamphlets, agenda, and reports..
13. INSTITUTIONAL RECORDS  
1873-1916  
Chronological.  
Five bound volumes of registers for Western State Hospital. Registers include admissions, discharges, and deaths of patients.

14. EPIDEMICS

1878-1897

Arranged by disease.

The original documents in the 29 files of this series have been retained. The bulk of this series is related to yellow fever epidemics in Memphis of 1879 and Knoxville in 1882. Four files are related to cholera, scarlet fever, and small pox. Materials included in this series are telegrams, correspondence, daily inspection reports of railroad passenger and freight, legal documents, expense reports, and circulars.

15. VITAL STATISTICS

1914-1944

Chronological

Forty-one files contain reports of deaths and some births for the years listed above. The bulk of the reports are in correspondence form by county for the year 1916. The chronology, 1903-1944, is interrupted at file 37 due to the oversized nature of the documents. The last five files, 1914-1926, do not contain names of the deceased, instead they are a record of deaths by a specific disease.

16. NURSING SECTION, TENNESSEE PUBLIC HEALTH ASSOCIATION

1954-1961

Alphabetical.

Eight files related to the Nurses Section of the Tennessee Public Health Association. Materials included are awards, memorials, scholarships, constitution, by-laws, minutes, treasurers report, correspondence, and a directory of officers.

17. MAPS & DRAWINGS

Undated

The two files of this series contain three sanitary community maps and one rare photograph of a Sulphur Fumigator Steam Engine, ca. 1900.
