## **INTRODUCTION**

Record Group 168, Financial Interest Statements, Tennessee State Senate, spans the period 1977-1990. The record group consists of Financial Interest Statements filed with the Chief Clerk of the State Senate. These statements were required under the Senate Code of Ethics. The documents contain very general information on each Senator regarding sources of income for the member, as well as family members, of over \$1500 per year. No specific information is given as to exact amount of income received. Also included is a disclosure requirement regarding any business done with the state by the member or any other family member in the same household. These reports were filed on an annual basis. The statements are arranged alphabetically by Senator's last name. Within each folder, the reports are arranged chronologically. As processed, Record Group 168 consists of .63 cubic feet.

Record Group 168 is available on microfilm only. After filming, the original documents were destroyed.
