SCOPE AND CONTENT NOTE

Record Group 177, Department of Insurance and Banking, Insurance Division, 1918-1985, consists of approximately 37 cubic feet of records. These records are divided by the sections they represent. Included in this collection are records on the Legal section, Insurance division, Licensing section, Examination section and the Loans and Securities section.

The Insurance Division acted to enforce the insurance laws of Tennessee. The division supervised all life, fire, casualty and other insurance companies authorized to transact business in this state, and the activities of the agents employed by those companies. As a part of the operations of the Insurance Division, this record group provides information on the Licensing and Examination sections. The Licensing section acts to screen applications for individuals to practice as insurance agents in Tennessee. In addition, this section collects taxes and fees from insurance companies and agents.

The Examination section is mandated by law to examine all aspects of a company's operations every three years. This examination reviews the financial status of the company, its attitude toward policy holders and the manner in which it complies with state law. The staff of this section participates in on-site visits to the home office of each company examined and can cooperate with examiners from other states at the home office of all out-of-state companies licensed in Tennessee.

Record Group 177 is divided into series and sub-series based on the functions of the offices of the division of Insurance. Not all records are available for all the series in this group. These records were reviewed and records were retained based on their documentation of the office for which they were created. Therefore, records not found in the collection for these years may not be available.
