SCOPE AND CONTENT NOTE

The records contained in Record Group 182, Tennessee Commission on Aging, span the period 1979 through 1994. The collection consists of approximately 3.5 cubic feet of material and is composed of audit reports and subject files.

The Tennessee Commission on Aging, created in 1963, collects facts and statistics related to conditions affecting the health and welfare of aging Tennesseans. It is responsible for promoting the exchange of ideas, disseminating information on aging, and encouraging and assisting the development of programs for older Tennesseans. In cooperation with local, state and federal governments, the commission promotes the coordination of programs for the aging and makes recommendations for improvements. The staff works with local communities through their agencies organizations and individuals to develop any needed services. It also administers the "Older Americans Act of Tennessee."

The bulk of Record Group 182 consists of audit reports of the "sub grantee" districts of Tennessee. The "sub grantee" districts operate nursing homes, senior centers, and other projects for elderly Tennesseans. The subject files detail the various activities of the commission, such as nutrition reports and the investigative reports of the Ombudsman office. In accordance with the Records Disposition Authorization (RDA), all material in Record Group 182 has been microfilmed and the originals were disposed of by state approved methods.
