SCOPE AND CONTENT NOTE

Record Group 183, Tennessee Children's Services Commission, spans the period 1949-1982. The record group consists of applications, biographical sketches of members, budget documents, certificates, constitution and by-Laws, correspondence, legislation, lists, minutes, personnel records, press releases, printed materials, programs, projects, reports and studies.

The Tennessee Children's Services Commission was formed on July 1, 1980, by a merger of the Tennessee Commission on Children and Youth and the Tennessee Office of Child Development. This record group primarily concentrates on the Tennessee Commission on Children and Youth and all prior, related agencies. For information on the Office of Child Development, see Record Group 169.

The Tennessee Children's Services Commission began as the Commission on Children on April 12, 1949. The Commission on Children was formed to study laws pertaining to the welfare of children and the interaction of various agencies providing services to children and youth. Its function was to find and evaluate facts, serve as a clearinghouse for information, and interpret the overall needs of children and youth by determining specific services, programs, or actions necessary to meet the needs. Further activities included planning for and promoting legislation; coordinating interests, services, and programs of citizen groups; and participating in the White House Conference on Children and Youth. The Commission was to report to the 1951 Legislature.

In 1953, the General Assembly passed a resolution to create the Children's Commission for a two year period. This commission was to outline the scope and authority of services to children.

The Tennessee Commission on Youth Guidance was created in 1955 by legislative act. It was charged with the same responsibilities as the Commission on Children, but was allowed to take a more active roll in the coordination of services between the various agencies. This commission served as the coordinating agency for the 1960 and 1970 White House Conference on Children and Youth, in addition to initiating several studies on services to children and youth.

In 1972, the Tennessee Commission on Children and Youth was formed. The commission was directed to collect facts and statistics, make special studies of conditions affecting the welfare and education of children and youth in the state, and keep abreast of the latest developments in this field of activity throughout the nation. It was responsible to interpret its findings to the public; to courts concerned with juvenile problems; and to all agencies, public and private, dealing with children. In addition to providing a mutual exchange of ideas and information on the national, state and local levels, the commission was to make recommendations for needed improvements and additional resources in the fields of child care, health, education, and recreation in the state and to serve as an advisory body in regard to new legislation.

The Children's Services Commission, created July 1, 1980 was a continuation of the work of the Commission on Children and Youth and the responsibilities from the Office of Child Development.

Record Group 183, Tennessee Children's Services Commission, is a diverse collection of materials concerning services provided to children and youth in Tennessee and gives a very detailed history of the commission's scope of activities.
