INTRODUCTION

The Treasurer's Office, Minutes of State Retirement System, 1947-1972, consists of three cubic feet of records created by the Tennessee State Treasurer's Office. These records were received from the state records center and found to be in excellent condition and original order. There are no restrictions on the use of these records. These records have been microfilmed and the original documents disposed of according to the Tennessee State RDA #528. This is a microfilm only collection.

SCOPE AND CONTENT

The Division of Retirement in 1972 was responsible to the State Treasurer and administered seven state-wide retirements systems according to the 1971-1972 Tennessee Blue Book. The seven systems were: Tennessee Teachers' Retirement System, Tennessee State Retirement System, Tennessee Judges Retirement System, Attorneys General Retirement System of Tennessee, Retirement System for County Paid Judges of Tennessee, Tennessee Retirement System for County Officials, and Public Service Commissioners' Retirement System; and, also the State Agency for Old Age and Survivors Insurance. The seven retirement systems had a membership of over one hundred thousand. The combined established monetary reserves in the Division of Retirement were in excess of four hundred million dollars. According to the 1973-1974 Tennessee Blue Book, these systems were consolidated into the Tennessee Consolidated Retirement System in 1972. At that time there were approximately 125,000 members with an accumulated retirement fund of over \$500,000,000.

This collection contains annual financial statements, agenda, minutes, and memoranda of the board of trustees. The third and twenty-first Annual Financial Statements are missing from this record group. Memoranda and correspondence are filed with the minutes of the meetings. Some overlapping of minutes exists between the Minute Books and the files of Agendas, Minutes, and Memoranda of Board Meetings. The Minute Books seem to contain the most complete record of minutes.
