INTRODUCTION

RG 328, Health Care Facilities Reports, 1991-2004, contain the Joint Annual Reports of health facilities that include Ambulatory Surgical Treatment Centers, 1991-2004, Assisted-Care Living Facilities, 1999-2004, Home Health, 1997-2002, Hospice, 1997-2004, Hospitals, 1996-2004, and Nursing Homes, 1996-2003. These records were received by the Tennessee State Library and Archives at various times between 1997 and 2010 for processing and microfilming. These records occupied 54 cubic feet of shelf space. The records were received in good condition and there are no restrictions on their use.

This record group has been microfilmed and the original records have been disposed of by the state approved method, in accordance with Records Disposition Authority #1530. This is a microfilm only collection.

SCOPE AND CONTENT

The Department of Health works to promote, protect and improve the health and well-being of Tennesseans. They work to insure the quality of health care through the licensure and regulation of health professionals and health care facilities. The department plays a critical role to ensure personal health care services are available when and where people need them the most despite economic and geographic barriers.

The arrangement of boxes 1 through 31.2 is chronological then alphabetical by county. The arrangement of the remainder of the collection uses a regional division system developed by the department. The department divided the state administratively by regions, starting with upper East Tennessee and ending in lower West Tennessee. These regions are sorted by a reference number on each box. The boxes are arranged by regions then chronologically and alphabetically by county.
